Dear Madam Secretary:

On March 5, officials from the State Department's Bureau of International Narcotics and Law Enforcement Affairs (INL) briefed Committee staff on issues raised in an Inspector General report regarding a State Department contract with DynCorp for police training in Iraq. The report, issued jointly on January 30, 2007, by the Special Inspector General for Iraq Reconstruction and the State Department's Inspector General, revealed waste and potential fraud with respect to a residential camp built for police trainers.¹

The Committee hereby requests copies of documents pertaining to the State Department's contracts with DynCorp. Specifically, the Committee requests that the Department produce copies of the following documents:

- (1) Preaward and postaward audits of proposals, billings, and confirmation of receipt of goods and services of all contracts and subcontracts with DynCorp, including analyses of all costs that were questioned or unsupported;
- (2) Reviews, assessments, or other analyses of DynCorp's performance as a State Department contractor or subcontractor, including analyses of inventory management, subcontractor management, asset management, and all other business systems;
- (3) Written and electronic correspondence with DynCorp or any of its subcontractors relating to Task Order 0338 of Contract Number S-LMAQM-04-C-0030, including stop orders,

cancellation orders, invoices, records of payment, requests for information and responses;
and

- (4) All emails to or from INL Contract Officer Representative Bob Gifford relating to DynCorp.

We request that you provide these documents as soon as possible, but in no case later than **Friday, March 30**. If you determine that you will be unable to make a complete production by this date, please contact Committee staff to discuss possible modifications to this schedule.

The Committee on Oversight and Government Reform is the principal oversight committee in the House of Representatives and has broad oversight jurisdiction as set forth in House Rule X. An attachment to this letter provides additional information on how to respond to the Committee's request.
