At the end of section 104 of the bill, add the following:

*ANNUAL PLAN*

1 (e) ~~ADDITIONAL MATTERS TO BE INCLUDED IN~~

3 (1) IN GENERAL.—~~In addition to any matter~~  
4 ~~otherwise required under this section, when devel-~~  
5 ~~oping a plan under subsection (a), (b), or (c), the~~  
6 Postal Service shall <sup>report annually on a state-by-state basis on</sup> consider the following factors in  
7 ~~making a determination with respect to whether to~~  
8 ~~close or consolidate a postal retail facility, mail proc-~~  
9 ~~essing facility, or area or district office (as the case~~

11 ~~(A) In connection with such closure or con-~~  
12 ~~solidation of a facility or office—~~

13 (i) the estimated total number of indi-  
14 viduals that would likely be separated from  
15 employment with the Postal Service as a  
16 result of such closure or consolidation (as  
17 the case may be); and

1 (ii) of the estimated total number  
2 under clause (i)—

3 (I) the estimated number and  
4 percentage comprising preference eli-  
5 gibles or veterans; and

6 (II) the estimated number and  
7 percentage comprising individuals  
8 other than preference eligibles or vet-  
9 erans.

10 (B) The opportunities for reemployment,  
11 within the general commuting area of the facil-  
12 ity or office involved, with—

13 (i) the Postal Service; and

14 (ii) employers apart from the Postal  
15 Service.

16 (C) The methodology and assumptions  
17 used to derive the estimates described in sub-  
18 paragraph (A).

19 (D) The criteria and process used to de-  
20 velop the information described in subpara-  
21 graph (B).

22 ~~(2) APPLICABILITY OF SAME REVIEW REQUIRE-~~  
23 ~~MENTS, ETC.—The information included in a plan as~~  
24 ~~required by paragraph (1) shall be subject to the~~  
25 ~~provisions of subsection (d) to the same extent and~~

1 ~~in the same manner as if required by subsection (a),~~  
2 ~~(b), or (c) (as the case may be).~~

3 (3) DEFINITIONS.—For purposes of this sub-  
4 section—

5 (A) the term “preference eligible” has the  
6 meaning given such term in section 2108(3) of  
7 title 5, United States Code; and

8 (B) the term “veteran” has the meaning  
9 given such term in section 101(2) of title 38,  
10 United States Code.
