Page 65, after line 25, insert the following:

1 (h) SAVINGS REPORT.—

2 (1) IN GENERAL.—In the event that a reduction
3 in door delivery points is required under this section,
4 the Authority shall submit a report to Congress, not
5 later than 1 year after the date on which such re-
6 ductions commence, describing the cost savings real-
7 ized to the date of such submission and the esti-
8 mated additional cost savings anticipated as a result
9 of such reductions occurring after such submission.

10 The report shall include—

11 (A) the measures taken to achieve the real-
12 ized savings and the assumptions and meth-
13 odologies used to compute the estimated cost
14 savings; and

15 (B) information with respect to what addi-
16 tional measures might be necessary to achieve
17 the cost savings required under this section.

18 (2) REDUCTION LIMITATION.—Notwithstanding
19 any other provision of this Act, if the Authority de-

1 termines that the measures described pursuant to
2 subparagraphs (A) and (B) of paragraph (1) are not
3 feasible, not cost effective, or otherwise detrimental
4 to the mail delivery policy of the Postal Service, the
5 Authority shall submit a report to Congress stating
6 any legislative changes recommended for door deliv-
7 ery modernization procedures under this section, in-
8 cluding increasing flexibility of this section's require-
9 ments or the postponement of further conversion.

At the end of section 211(i)(3) of the bill insert the following:

- 1 (G) CONTRACT LIMITATION.—
- 2 (i) IN GENERAL.—Any contract for
- 3 goods or services entered into by the Post-
- 4 al Service within 6 months after the date
- 5 on which any reduction in force authorized
- 6 by this subsection commences shall include
- 7 a requirement that individuals described
- 8 under clause (ii) receive a hiring pref-
- 9 erence.
- 10 (ii) PREFERENCE.—To qualify for the
- 11 preference authorized under clause (i), an
- 12 individual must have been separated from
- 13 the Postal Service—
- 14 (I) as part of a reduction in force
- 15 authorized by this subsection;
- 16 (II) as a nonretirement eligible
- 17 employee; and

1 (III) for a period of time that is
2 not greater than 78 weeks, beginning
3 on the date of such separation.
