Dear Mr. Bershteyn:

We received a response from the Office of Information and Regulatory Affairs (OIRA) to our letter dated September 21, 2012, which inquired, among other things, about the status of the long overdue Spring 2012 Unified Agenda of Regulatory and Deregulatory Actions (Unified Agenda) and the 2012 Report to Congress on the Benefits and Costs of Federal Regulations (Benefits and Costs Report). We are disappointed that OIRA failed to adequately respond to our questions. Further, the documents that provide basic regulatory transparency, and are required to be published by law, remain outstanding.

In our letter, we specifically asked about the status and expected publication date of the Spring 2012 Unified Agenda as well as the Benefits and Costs Report. Unfortunately, we did not receive specific answers. Instead, OIRA gave vague excuses about the documents tardiness and a statement that raises questions about executive branch agencies' ability to comply with OIRA deadlines. Specifically, the OIRA response letter states, "[a]gencies are currently compiling the most updated information about their anticipated regulatory actions since the [Unified] Agenda was last published "3 This is puzzling because as noted in our letter, OIRA set April 13, 2012, as a "firm deadline" for this information. Apparently, either agencies ignored OIRA's direction or the information is being withheld from Congress and the public.

In 2010, President Obama boasted, "I won't stop fighting to open up government," adding that this Administration has "put in place the . . . toughest transparency rules of any Administration in history." Moreover, this Administration has claimed it will alleviate regulatory uncertainty as well as unnecessary regulation. But this Administration has failed to live up to its own transparency standards by failing to release basic regulatory documents which provide transparency about agencies' plans to regulate and allow the public to assess the regulatory state.

This lack of transparency raises questions about the motives behind the Administration's apparent reluctance to inform Congress and the public about its regulatory plans. Due to the impending election, it does raise concerns that the Administration is holding back this information for fear it will be met with dissatisfaction by the public, or even worse, perceived as breaking the Administration's promise of regulatory reform.⁷

To lay these questions to rest, we request a staff briefing by November 2, 2012, to further explain the documents continued embargo. Further, the briefing should address whether OIRA has provided agencies with any direction or guidance regarding midnight rulemaking.
