**A BILL**

To amend the Internal Revenue Code of 1986 to impose a tax on the total revenue of manufacturers and importers of semi-automatic assault weapons.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4 (a) SHORT TITLE.—This Act may be cited as the  
5 “Firearm Industry Fairness Act”.

6 (b) FINDINGS.—Congress finds the following:

7 (1) AR-15s are abnormally dangerous weapons  
8 meant for the battlefield. AR-15-style rifles have

1        been the weapon of choice for the killers responsible  
2        for the deadliest mass shootings in American his-  
3        tory, including the recent mass murders in Buffalo,  
4        New York, Uvalde, Texas, and Highland Park, Illi-  
5        nois.

6            (2) Major gun manufacturers have been enjoy-  
7        ing record-breaking sales and profits from AR-15-  
8        style rifles, even as gun deaths and mass shootings  
9        have risen in the United States. Studies have shown  
10       that gun violence and the human and economic toll  
11       associated with the more than 40,000 annual fire-  
12       arm deaths in America are strongly correlated with  
13       the availability of firearms.

14           (3) Large capacity magazines have been shown  
15       to lead to increasingly deadly mass shootings be-  
16       cause they allow the shooter to continue firing for  
17       longer periods of time and reduce the opportunities  
18       for law enforcement or other bystanders to intervene  
19       to stop the killing.

20           (4) Despite widespread diversion of weapons  
21       from major manufacturers to unlawful use, the fire-  
22       arm industry has failed to monitor the downstream  
23       distribution of their weapons to distributors or other  
24       sellers, with the result that an inordinate number of

1 guns used in crimes of violence are funneled through  
2 a small number of dealers.

3 (5) An investigation into the gun industry's  
4 practices and profits by the Committee on Oversight  
5 and Reform found that five leading gun manufactur-  
6 er's collected more than \$1,000,000,000 from the  
7 sale of AR-15-style weapons in the last decade.

8 **SEC. 2. TAX ON TOTAL REVENUE OF MANUFACTURERS AND**  
9 **IMPORTERS OF SEMI-AUTOMATIC ASSAULT**  
10 **WEAPONS.**

11 (a) IN GENERAL.—Subtitle A of the Internal Rev-  
12 enue Code of 1986 is amended by inserting after chapter  
13 6 the following new chapter:

14 **“CHAPTER 7—MANUFACTURERS AND IM-**  
15 **PORTERS OF SEMI-AUTOMATIC AS-**  
16 **SAULT WEAPONS**

“Sec. 1571. Imposition of tax on total revenue.

17 **“SEC. 1571. IMPOSITION OF TAX ON TOTAL REVENUE.**

18 “(a) IN GENERAL.—There is hereby imposed (in ad-  
19 dition to any other tax imposed by this title) for each tax-  
20 able year a tax equal to 20 percent of the total revenue  
21 of each semi-automatic assault weapons manufacturer or  
22 importer.

1           “(b) TOTAL REVENUE.—For purposes of this section,  
2 the term ‘total revenue’ means total gross receipts reduced  
3 by the cost of goods sold.

4           “(c) SEMI-AUTOMATIC ASSAULT WEAPONS MANU-  
5 FACTURER OR IMPORTER.—For purposes of this section—

6           “(1) IN GENERAL.—The term ‘semi-automatic  
7 assault weapons manufacturer or importer’ means,  
8 with respect to any taxable year, any manufacturer,  
9 producer, or importer (within the meaning of section  
10 4181) of any semi-automatic assault weapon or large  
11 capacity ammunition feeding device, and any person  
12 related to any such manufacturer, producer, or im-  
13 porter, if the aggregate number of semi-automatic  
14 assault weapons and large capacity ammunition  
15 feeding devices manufactured, produced, or imported  
16 by such manufacturer, producer, or importer (and  
17 all persons related to such manufacturer, produce,  
18 or importer) during such taxable year exceeds 100.

19           “(2) EXCEPTION.—For purposes of determining  
20 under paragraph (1) the number of such weapons  
21 and devices manufactured, produced, or imported by  
22 any person, there shall not be taken into account  
23 any such weapon or device manufactured, produced,  
24 or imported solely for use by the United States gov-  
25 ernment, any State or local government, or any de-

1       partment, agency, or political subdivision thereof.  
2       The Secretary shall prescribe such regulations and  
3       other guidance as is necessary to prevent avoidance  
4       of the purposes of this paragraph.

5           “(3) RELATED PERSONS.—A person shall be  
6       treated as related to another person if such person  
7       is in the same controlled group (within the meaning  
8       of section 1563(a), applied by substituting ‘more  
9       than 50 percent’ for ‘at least 80 percent’ each place  
10      it appears therein) as such other person. Under reg-  
11      ulations or other guidance prescribed by the Sec-  
12      retary, principles similar to the principles of the pre-  
13      ceding sentence shall apply to a group of persons  
14      under common control where 1 or more of such per-  
15      sons is not a corporation.

16          “(d) SEMI-AUTOMATIC ASSAULT WEAPONS; LARGE  
17      CAPACITY AMMUNITION FEEDING DEVICE.—For pur-  
18      poses of this section—

19           “(1) SEMI-AUTOMATIC ASSAULT WEAPON.—The  
20      term ‘semi-automatic assault weapon’ means any of  
21      the following, regardless of country of manufacture  
22      or caliber of ammunition accepted:

23                  “(A) A semiautomatic rifle that—

24                          “(i) has the capacity to accept a de-  
25                          tachable ammunition feeding device; and

1 “(ii) has any 1 of the following:

2 “(I) A pistol grip.

3 “(II) A forward grip.

4 “(III) A folding, telescoping, or  
5 detachable stock, or a stock that is  
6 otherwise foldable or adjustable in a  
7 manner that operates to reduce the  
8 length, size, or any other dimension,  
9 or otherwise enhances the  
10 concealability, of the weapon.

11 “(IV) A grenade launcher.

12 “(V) A barrel shroud.

13 “(VI) A threaded barrel.

14 “(B) A semiautomatic rifle that has a  
15 fixed ammunition feeding device with the capac-  
16 ity to accept more than 15 rounds, except for  
17 an attached tubular device designed to accept,  
18 and capable of operating only with, .22 caliber  
19 rimfire ammunition.

20 “(C) Any part, combination of parts, com-  
21 ponent, device, attachment, or accessory that is  
22 designed or functions to accelerate the rate of  
23 fire of a semiautomatic firearm but not convert  
24 the semiautomatic firearm into a machinegun.

25 “(D) A semiautomatic pistol that—

1                   “(i) has an ammunition feeding device  
2                   that is not a fixed ammunition feeding de-  
3                   vice; and

4                   “(ii) has any 1 of the following:

5                                 “(I) A threaded barrel.

6                                 “(II) A second pistol grip.

7                                 “(III) A barrel shroud.

8                                 “(IV) The capacity to accept a  
9                   detachable ammunition feeding device  
10                  at some location outside of the pistol  
11                  grip.

12                                “(V) A semiautomatic version of  
13                  an automatic firearm.

14                                “(VI) A manufactured weight of  
15                  50 ounces or more when unloaded.

16                                “(VII) A buffer tube, stabilizing  
17                  brace or similar component that pro-  
18                  trudes horizontally behind the pistol  
19                  grip, and is designed or redesigned to  
20                  allow or facilitate a firearm to be fired  
21                  from the shoulder.

22                                “(E) A semiautomatic pistol with a fixed  
23                  ammunition feeding device that has the capac-  
24                  ity to accept more than 15 rounds.

25                                “(F) A semiautomatic shotgun that—

1 “(i) has the capacity to accept a de-  
2 tachable ammunition feeding device or a  
3 fixed ammunition feeding device that has  
4 the capacity to accept more than 5 rounds;  
5 and

6 “(ii) has any 1 of the following:

7 “(I) A folding, telescoping, or de-  
8 tachable stock.

9 “(II) A pistol grip or bird’s head  
10 grip.

11 “(III) A forward grip.

12 “(IV) A grenade launcher.

13 “(G) Any shotgun with a revolving cyl-  
14 inder.

15 “(H) All of the following rifles, copies, du-  
16 plicates, variants, or altered facsimiles with the  
17 capability of any such weapon thereof:

18 “(i) All AK types, including the fol-  
19 lowing:

20 “(I) AK, AK47, AK47S, AK-74,  
21 AKM, AKS, ARM, MAK90, MISR,  
22 NHM90, NHM91, Rock River Arms  
23 LAR-47, SA85, SA93, Vector Arms

7           “(2) LARGE CAPACITY AMMUNITION FEEDING  
8           DEVICE.—The term ‘large capacity ammunition  
9           feeding device’—

10           “(A) means a magazine, belt, drum, feed  
11           strip, or similar device, including any such de-  
12           vice joined or coupled with another in any man-  
13           ner, that has an overall capacity of, or that can  
14           be readily restored, changed, or converted to ac-  
15           cept, more than 15 rounds of ammunition; and

16           “(B) does not include an attached tubular  
17           device designed to accept, and capable of oper-  
18           ating only with, .22 caliber rimfire ammunition.

19           “(3) OTHER DEFINITIONS.—

20           “(A) SEMIAUTOMATIC PISTOL.—The term  
21           ‘semiautomatic pistol’ means any repeating pis-  
22           tol that—

23           “(i) utilizes a portion of the energy of  
24           a firing cartridge to extract the fired car-

1                   tridge case and chamber the next round;

2                   and

3                   “(ii) requires a separate pull of the  
4                   trigger to fire each cartridge.

5                   “(B) SEMIAUTOMATIC SHOTGUN.—The  
6                   term ‘semiautomatic shotgun’ means any re-  
7                   peating shotgun that—

8                   “(i) utilizes a portion of the energy of  
9                   a firing shell to extract the fired shell cas-  
10                  ing and chamber the next round; and

11                  “(ii) requires a separate pull of the  
12                  trigger to fire each shell.

13                  “(C) BARREL SHROUD.—The term ‘barrel  
14                  shroud’—

15                  “(i) means a shroud that is attached  
16                  to, or partially or completely encircles, the  
17                  barrel of a firearm so that the shroud pro-  
18                  tects the user of the firearm from heat  
19                  generated by the barrel; and

20                  “(ii) does not include—

21                          “(I) a slide that partially or com-  
22                          pletely encloses the barrel; or

23                          “(II) an extension of the stock  
24                          along the bottom of the barrel which

1                   does not encircle or substantially en-  
2                   circle the barrel.

3                   “(D) DETACHABLE AMMUNITION FEEDING  
4                   DEVICE.—The term ‘detachable ammunition  
5                   feeding device’ means an ammunition feeding  
6                   device that can be removed from a firearm  
7                   without disassembly of the firearm action.

8                   “(E) FIXED AMMUNITION FEEDING DE-  
9                   VICE.—The term ‘fixed ammunition feeding de-  
10                  vice’ means an ammunition feeding device that  
11                  is contained in and not removable from or is  
12                  permanently fixed to the firearm, but does not  
13                  include an attached tubular device designed to  
14                  accept, and capable of operating only with, .22  
15                  caliber rimfire ammunition.

16                  “(F) FOLDING, TELESCOPING, OR DE-  
17                  TACHABLE STOCK.—The term ‘folding, tele-  
18                  scoping, or detachable stock’ means a stock  
19                  that folds, telescopes, detaches or otherwise op-  
20                  erates to reduce the length, size, or any other  
21                  dimension, or otherwise enhances the  
22                  concealability, of a firearm.

23                  “(G) FORWARD GRIP.—The term ‘forward  
24                  grip’ means a grip located forward of the trig-  
25                  ger that functions as a pistol grip.

1           “(H) GRENADE LAUNCHER.—The term  
2 ‘grenade launcher’ means an attachment for use  
3 on a firearm that is designed to propel a gre-  
4 nade or other similar destructive device.

5           “(I) PISTOL GRIP.—The term ‘pistol grip’  
6 means a grip, a thumbhole stock or Thordsen-  
7 type grip or stock, or any other characteristic  
8 that can function as a grip.

9           “(J) THREADED BARREL.—The term  
10 ‘threaded barrel’ means a feature or char-  
11 acteristic that is designed in such a manner to  
12 allow for the attachment of a device such as a  
13 firearm silencer or a flash suppressor.

14           “(K) BELT-FED SEMIAUTOMATIC FIRE-  
15 ARM.—The term ‘belt-fed semiautomatic fire-  
16 arm’ means any repeating firearm that—

17           “(i) utilizes a portion of the energy of  
18 a firing cartridge to extract the fired car-  
19 tridge case and chamber the next round;

20           “(ii) requires a separate pull of the  
21 trigger to fire each cartridge; and

22           “(iii) has the capacity to accept a belt  
23 ammunition feeding device.

24           “(L) OTHER TERMS.—Terms used in this  
25 subsection which are also used in section 921 of

1 title 18, United States Code, shall have the  
2 same meaning as when used in such section.”.

3 (b) CLERICAL AMENDMENT.—The table of chapters  
4 for subtitle A of such Code is amended by inserting after  
5 the item relating to chapter 6 the following new item:

“CHAPTER 7. MANUFACTURERS AND IMPORTERS OF SEMI-AUTOMATIC  
ASSAULT WEAPONS.”.

6 (c) EFFECTIVE DATE.—The amendments made by  
7 this section shall apply to taxable years beginning after  
8 the date of the enactment of this Act.

9 **SEC. 3. FUNDING COMMUNITY VIOLENCE INTERVENTION**  
10 **AND PREVENTION.**

11 (a) COMMUNITY VIOLENCE INTERVENTION AND PRE-  
12 VENTION TRUST FUND.—Subchapter A of chapter 98 is  
13 amended by adding at the end the following new section:

14 **“SEC. 9512. COMMUNITY VIOLENCE INTERVENTION AND**  
15 **PREVENTION TRUST FUND.**

16 “(a) CREATION OF TRUST FUND.—There is estab-  
17 lished in the Treasury of the United States a trust fund  
18 to be known as the ‘Community Violence Intervention and  
19 Prevention Trust Fund’, consisting of such amounts as  
20 may be appropriated or credit to such Trust Fund as pro-
