Dear Ms. Secretary:

We write to request that you provide us the names and relevant biographical information of the employees who serve on your agency's Regulatory Reform Task Force.<sup>1</sup> On February 24, 2017, President Donald Trump issued Executive Order 13777, which requires each agency to create a Regulatory Reform Task Force to "evaluate existing regulations," "make recommendations to the agency head regarding their repeal, replacement, or modification," and identify regulations that "eliminate jobs, or inhibit job creation," "are outdated, unnecessary, or ineffective," or "impose costs that exceed benefits."<sup>2</sup> Accordingly, employees who serve on these Task Forces may play a significant role in proposing regulatory changes over the course of the Trump Administration.<sup>3</sup>

On August 7, 2017, we requested the names of Task Force participants from the Director of the Office of Management and Budget and the Administrator of the Office of Information and Regulatory Affairs. As we noted in our request, "the interests of the American public must be paramount when reviewing the worthiness of regulations," and it is therefore critical that these Task Forces maintain guards "against conflicts of interest, especially those in which industry lobbyists seek to overturn environmental and health protections for financial gain."<sup>4</sup> To date, we have received no response to this request.

Although some agencies have disclosed their Task Force members, your agency has not. In order to fulfill our congressional oversight responsibilities, we respectfully request that you
