Dear Mr. Chairman:

I am writing to request that you issue subpoenas to eight federal agencies that are refusing to disclose to Congress the members of their Regulatory Reform Task Forces. One of our key responsibilities on this Committee is to conduct vigorous oversight to protect against conflicts of interest that have the potential to alter federal policy to benefit corporate and other interests rather than the interests of the American people, and it should not take the better part of a year just to obtain this basic information.

On February 24, 2017, President Donald Trump issued Executive Order 13777, which required each agency to create a Regulatory Reform Task Force to “evaluate existing regulations,” “make recommendations to the agency head regarding their repeal, replacement, or modification,” and identify regulations that “eliminate jobs, or inhibit job creation,” “are outdated, unnecessary, or ineffective,” or “impose costs that exceed benefits.”<sup>1</sup>

Employees who serve on these Task Forces may play a significant role in proposing regulatory changes over the course of the Trump Administration.<sup>2</sup>

On August 7, 2017, I sent a letter to the Director of the Office of Management and Budget and the Administrator of the Office of Information and Regulatory Affairs, along with Ranking Members John Conyers, Jr., Gerald E. Connolly, and David Cicilline, requesting the identities of Task Force participants. As we noted in our request, “the interests of the American public must be paramount when reviewing the worthiness of regulations,” and it is critical that these Task Forces guard “against conflicts of interest, especially those in which industry

lobbyists seek to overturn environmental and health protections for financial gain.”<sup>3</sup> We received no response to our request.

On February 7, 2018, I sent letters, along with Ranking Members Jerrold Nadler, Connolly, and Cicilline, to the 12 agencies that still had not disclosed the identities of their Task Force members. We requested the identities of their Task Force members by February 20, 2018.<sup>4</sup>

In response to our requests, four agencies provided the information we requested, but the following eight agencies provided no response:

Department of Commerce  
Department of Homeland Security  
Department of Justice  
Department of Labor  
Department of State  
General Services Administration  
Small Business Administration  
Social Security Administration

For these reasons, I now ask that you issue subpoenas to compel these eight agencies to produce documents sufficient to identify the members of their Regulatory Reform Task Forces. If you choose not to do so, then I ask you to place this matter on the agenda for our next regularly scheduled business meeting so all Committee members will have the opportunity to vote on a motion to subpoena the agencies for this information.
