Dear Mr. Rymer:

Recent media reports indicate that the Department's Office of the Inspector General (OIG) is "investigating allegations that military officials have skewed intelligence assessments about the United States-led campaign in Iraq against the Islamic State to provide a more optimistic account of progress"¹ We are deeply concerned about these allegations and want to ensure that intelligence provided to key decision makers properly reflect the expert analysis produced by our Intelligence Community (IC) professionals.

We are also troubled to learn of allegations that those in the IC who sought to improve the situation were met with political roadblocks, "urged to retire," or left on their own.² Retaining our trained and experienced intelligence analysts is an important factor in maintaining a strong IC capable of preempting threats and furthering our national security objectives.

Because of these concerns, we request the OIG designate appropriate officials to provide a briefing to the Committee staff as soon as possible, but no later than 5:00 p.m. on September 18, 2015 to provide updates of the investigation and its findings to this Committee.

The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and may at "any time" investigate "any matter" as set forth in House Rule X. An attachment to this letter provides additional information about responding to the Committee's request.
