

**AMENDMENT TO H. R. 10****OFFERED BY M**\_\_ . \_\_\_\_\_

Page 10, strike line 18 and all that follows through  
page 11, line 6 and insert the following:

1                   “(iii) In the case of a school that, as  
2                   of the date of enactment of the SOAR Re-  
3                   authorization Act, is not a participating  
4                   school, the school meets the requirements  
5                   of clause (i) or, if it does not meet the re-  
6                   quirements of clause (i)—

7                   “(I) at the time the school noti-  
8                   fies an eligible entity that it seeks to  
9                   be a participating school, the school is  
10                  actively pursuing full accreditation by  
11                  an accrediting body described in  
12                  clause (i);

13                  “(II) not later than 5 years after  
14                  the school notifies an eligible entity  
15                  that it seeks to be a participating  
16                  school, the school meets the require-  
17                  ments of clause (i), except that an eli-  
18                  gible entity may extend this deadline  
19                  for a single 1-year period if the school

1 provides the eligible entity with evi-  
2 dence from such an accrediting body  
3 that the school's application for ac-  
4 creditation is in process and that the  
5 school will be awarded accreditation  
6 before the end of such period; and  
7 “(III) the school meets all of the  
8 other requirements for participating  
9 schools under this Act”.

Page 14, strike lines 3 through 13 and insert the following:

10 “(d) PERMITTING USE OF FUNDS REMAINING UN-  
11 OBLIGATED FROM PREVIOUS FISCAL YEARS.—To the ex-  
12 tent that any funds appropriated for the opportunity  
13 scholarship program under this Act for any fiscal year (in-  
14 cluding a fiscal year occurring prior to the enactment of  
15 this subsection) remain unobligated at the end of the fiscal  
16 year, the Secretary shall make such funds available during  
17 the next fiscal year and (if still unobligated as of the end  
18 of that fiscal year) any subsequent fiscal year for scholar-  
19 ships for eligible students, except that an eligible entity  
20 may use not more than 5 percent of the funds for adminis-  
21 trative expenses, parental assistance, and tutoring, in ad-  
22 dition to the amounts appropriated for such purposes  
23 under section 3007(b) and (c).”.

Page 17, line 17, strike “their satisfaction with their child’s school” and insert “the satisfaction of such parents and students with their choice”.

Page 17, line 23, strike “college admission” and insert “college enrollment”.

Page 18, beginning line 3, strike “college admission” and insert “college enrollment”.

Page 19, line 15, strike “such student,” and insert the following: “such student or the group of individuals providing information for carrying out the evaluation of such student,”.
