Dear Mr. Dodaro:

On October 27, 2015, the Information Technology Subcommittee held a hearing to examine the interoperability of health care records between the Department of Veterans Affairs (VA) and the Department of Defense (DoD). The VA is responsible for providing Veterans with, as Secretary McDonald put it, “the high quality service that they’ve earned.”<sup>1</sup> In carrying out this responsibility, the VA relies on its electronic health information system—the Veterans Health Information Systems and Technology Architecture (VistA)—which consists of more than 100 separate computer applications.

Over the past 15 years, VA has undertaken various initiatives to modernize or replace VistA, starting in 2001 with a program referred to as HealtheVet. This initiative was followed by a 2011 joint effort with DoD to develop the interoperable electronic health record (iEHR), followed by a 2013 effort with VistA Evolution. However, these efforts, just to name a few, have not produced the kinds of modern systems and capabilities that Congress mandated. Moreover, VA has recently indicated that it may be pursuing yet another modernization initiative.

Given the significance of VA’s electronic health record information system to the performance of its health care mission, and in light of VA’s repeated attempts to modernize VistA, the Subcommittee is requesting information on the efforts to modernize VistA. We request that the Government Accountability Office conduct a study of the VistA modernization project. In particular, we would like to receive information on the history of VA’s efforts to modernize VistA, including the costs and results of the efforts, the key contractors that have been involved, and the work that these contractors performed. In addition, we ask that the study determine VA’s current plans and estimated costs for modernizing VistA.
