22	(1) Initial Report.—Not later than 180 days
23	after the date of the enactment of this Act, the

2	ment Reform of the House of Representatives, and
3	the Committee on Homeland Security and Govern-
4	mental Affairs of the Senate a report—
5	(A) on the results of the review conducted
6	under subsection (a); and
7	(B) including recommendations on improv-
8	ing Federal contractor compliance with the laws
9	listed under such subsection.
10	(2) Second Report.—Not later than one year
11	after the date on which the Director of the Office of
12	Management and Budget issues procedures under
13	subsection (e)(1) of section 1710 of title 41, United
14	States Code, as amended by section 3(a), the Comp-
15	troller General of the United States shall submit to
16	the Director of the Office of Management and Budg-
17	et, the Committee on Oversight and Government Re-
18	form of the House of Representatives, and the Com-
19	mittee on Homeland Security and Governmental Af-
20	fairs of the Senate an updated report on the matters
21	described in paragraph (1).
