Dear Deputy Attorney General Rosenstein and Director Wray:

We have questions about the tactics used to apprehend Roger Stone last week. Early on the morning of January 25, 2019, a FBI tactical assault team arrested Roger Stone at his home in South Florida.<sup>1</sup> Numerous FBI agents with automatic rifles and full tactical assault gear conducted the arrest.<sup>2</sup> Stone had suspected his indictment was looming, and made no effort to elude authorities—in fact, Stone has said he would have voluntarily surrendered.<sup>3</sup> These raids are dangerous, and they pose serious risks to the officers, the arrestee and his family, and the community.<sup>4</sup>

According to the National Tactical Officers Association, tactical officers should be used to “resolve critical incidents involving a threat to public safety which would otherwise exceed the capabilities of traditional law enforcement first responders and/or investigative units.”<sup>5</sup> Tactical units differ from traditional law enforcement efforts: “[t]he primary characteristic of such teams that distinguishes them from other units is the focus of effort.”<sup>6</sup>

Given Stone’s advanced age and the nature of charges against him, as well as his statement that he would have surrendered voluntarily, it is unsettling that the Justice Department chose to use agents in full tactical assault gear to arrest Stone. In addition, the presence and proximity of television news cameras during Stone’s arrest raise questions about whether any Justice Department or FBI personnel alerted the media about Stone’s imminent arrest. The Department of Justice Office of Inspector General has been reviewing a series of unauthorized disclosures to news organizations from the Comey era.<sup>7</sup>

We request a briefing about the Department’s tactics used to apprehend Stone, and the approval process for the use of those tactics. We also seek to learn whether any Department personnel disclosed law enforcement sensitive or grand jury information regarding Stone’s arrest to CNN. Please be prepared to brief us on the following issues:

1. Identify the senior-most Department official who specifically authorized the raid.
2. The Department’s and FBI’s protocols and standards in determining whether a tactical unit is needed to execute an arrest.
3. The Department’s and FBI’s decision-making process in approving the use of a tactical unit to arrest Roger Stone on January 25, 2019, including the timeline of this decision-making process.

4. Information relating to the decision to notify new organizations of the impending arrest, and the steps taken by the Department and FBI to date to determine whether Department personnel violated any rules or guidelines in doing so.
5. Whether any Department personnel disclosed grand jury information to anyone outside of the Department and FBI in relation to the arrest of Roger Stone?

We look forward to your briefing as soon as possible but no later than 5:00 p.m. on February 15, 2019. Thank you for your attention to this important matter.
