Dear Chairwoman Maloney:

We respectfully request a hearing on the violence directed at supporters of President Trump on November 14, 2020. These supporters were exercising their First Amendment right to peaceably assemble within the District of Columbia. The failure of the city's leaders to afford basic protections to persons who may hold different political viewpoints from their own appears to be another concerning example of viewpoint discrimination in the District.

On November 14, thousands of supporters of President Trump travelled to the District of Columbia to participate in First Amendment activities.¹ However, they were faced with harassment by left-wing counter-protestors which included violent assaults.² Others were pelted with eggs and unknown liquids.³ Still others endured attacks with fireworks while they were dining.⁴ Reports indicate that Trump supporters were harassed by Antifa counter-protestors culminating in fistfights and a stabbing resulting in critical injuries.⁵ Videos show several incidents of Antifa counter-protestors surrounding and threatening Trump supporters while taking their property.⁶ Reports also indicate that two police officers were assaulted.⁷

Despite the violence, the mainstream media and liberal establishment were quick to minimize the seriousness of the use of violence against Trump supporters by deriding them for failing to wear masks in the midst of the coronavirus pandemic, and asserting that they were infiltrated by "white nationalists, conspiracy theorists, and far right activists..." City leaders have remained silent on the violence. This growing level of violence directed at others simply for holding different views is unacceptable.

We are especially concerned given a broader pattern of viewpoint discrimination in the District of Columbia. For example, this past summer, the Mayor permitted protestors to spray paint "Defund the Police" on a city street in June where it remained until August, 9 yet pro-life protestors were arrested for writing messages on a sidewalk in chalk. 10

It is essential that any group exercising their right to peaceably assemble—no matter their viewpoints—be afforded basic protections against violence. It is also essential that the safety of nonparticipants, as well as property within the District, be protected. Although these are basic and fundamental expectations, the city's leaders have repeatedly failed and/or refused to meet them.

Our Committee must conduct oversight to determine whether the District of Columbia has a plan to ensure that violence is not tolerated against those who come to our nation's capital in the future to exercise their First Amendment rights. We therefore request that the Committee hold a hearing on this important matter before the end of the 116th Congress. We look forward to working with you to plan and prepare for this requested hearing.
