Dear Madam Speaker:

We write to demand you immediately reopen the U.S. Capitol complex to the public. The U.S. Capitol is a shrine to the greatest republic in the history of the world, yet you continue to prevent easy access to the American people.

For well over a year and a half, "the U.S. Capitol Building and Congressional Office Buildings [have] remain[ed] closed to the public." Only Members, congressional staff, and invited, official business visitors are allowed in the Capitol and House Office Buildings. The U.S. Capitol Visitor Center's sole purpose is to accommodate visitors, but it also remains closed, and no tours are authorized. Official business visitors must be pre-arranged and met by House staff at the designated entrance, present their identification, and check-in at the Appointments Desk. It is not clear what is done with their information prior to or after their visit, nor is it apparent who has access to the visitor log database, the very existence of which has a potential chilling effect. They must be escorted throughout their visit by congressional staff or a Member of Congress, limiting their ability to freely enjoy the grounds. Ordinary Americans who wish to visit the People's House – which their tax dollars maintain – are entirely shut out and may only view the buildings from afar. This is the People's House, but the American people are not allowed to enter.

This extended closure has had real consequences on Americans' most fundamental constitutional rights. Citizens who wish to visit the Capitol complex to exercise their First Amendment rights to freedom of speech, peaceably to assemble, or to petition the Government are prohibited from readily doing so.⁴ While the Constitution strictly prohibits Congress from passing a law infringing these rights, you appear to have usurped our founding document by prohibiting exercise of these rights through an authoritarian decree.

Such a decree impacts the ability of individuals, advocacy groups, businesses, and others to lobby their representatives. The closure prevents the public from enjoying the Capitol complex's architectural wonders, art, statues, and other historical relics of our great nation, and it once again artificially separates the peoples' representatives from those whose interests they were sent here to champion.

Though the visitor policy was initially restricted due to the COVID-19 pandemic, it is now time to follow the lead of the rest of the country and reopen the People's House. Your closure has continued despite safe and effective vaccines, treatments, and testing being widely available to most of the population for almost a year. Indeed, the Centers for Disease Control and Prevention tracks that 80.8 percent of people aged 12 and over have had at least one dose of a vaccine. The Smithsonian museums and other attractions on the National Mall are once again open to the public. Why are you unnecessarily keeping the People's House closed?

Unfortunately, COVID-19 has become the pretext by which Democrats attempt to assert control over every aspect of American life. Shuttering schools and small businesses was bad enough without also shuttering the people's access to their elected representatives. It is well past time to reopen the House of Representatives, and we urge you to open it immediately so all Americans may once again fully participate in our great democracy.
