Dear Chairwoman Maloney:

On January 19, 2022—during a public hearing—you told us: "If you would like another [hearing], request it, and we will have another [hearing] on Afghanistan."¹ You further claimed:

On Afghanistan, we have held a briefing with the Special Inspector General for Afghanistan [Reconstruction] (SIGAR), we have had a classified briefing at the request of the minority with the Defense Department, State Department, [the Department of Homeland Security], and [the] Intelligence Community, and we had another one in the National [Security] Subcommittee with Chairman Lynch.²

To be clear: (1) Committee Republicans requested the briefing with SIGAR, (2) the classified briefing did not satisfy our request for a "hearing," and (3) the scope of the National Security Subcommittee hearing was changed at the last minute to no longer specifically include Afghanistan.³

Unfortunately, the Committee has not held a single public event on the disastrous withdrawal from Afghanistan. Not one. The complete lack of oversight is conspicuously surprising considering the Committee's consistent and bipartisan engagement on Afghanistan—including your own—prior to the Biden Administration's botched withdrawal. Rather than pursue transparency and accountability, Committee Democrats have remained idle. Meanwhile, the situation in Afghanistan and the region continues to worsen:

- Americans—abandoned by the Biden Administration—are still stranded in Afghanistan and the United Arab Emirates;⁴
- The Taliban are causing a mass hunger and humanitarian crisis, which threatens to kill millions;⁵
- The Taliban continue to rapidly dismantle gains in the rights of women and girls;⁶
- Random acts of violence are consuming daily life;⁷ and,
- The Taliban are attempting to install friendly envoys in embassies worldwide;⁸

Committee Democrats must step up, do their job, and hold the Biden Administration accountable, even if it is politically inconvenient. Pursuant to your statement above, we therefore again request a full committee—public and in-person—hearing on the Biden Administration's withdrawal from Afghanistan and the aftermath. Furthermore, we request that you call the following witnesses to testify:

- The Honorable Antony Blinken Secretary U.S. Department of State
- The Honorable Lloyd Austin Secretary U.S. Department of Defense
- Mr. Jake Sullivan Assistant to the President for National Security Affairs The White House
