Res. 5, the issues outlined in the Committee on Oversight and Accountability's (f.k.a. the Committee on Oversight and Reform) December 13, 2022, letter to you now fall under the purview of both the Committee and the Select Subcommittee on the Coronavirus Pandemic.¹ As such, we renew the December 13th requests to be produced as soon as possible but no later than February 20, 2023. 4. All documents and communications between or among any agency or federal entity, or any sub-agencies, sub-awardees, or affiliates and EcoHealth Alliance, or any of its subsidiaries or affiliates, regarding grant R01AI110964.

6. All documents and communications regarding the Potential Pandemic Pathogen Care and Oversight Framework, including but not limited to the creation and formation of the Framework, the membership of the Board, and the referral or lack thereof of any EcoHealth grant to the Board.
7. All documents and communications regarding the U.S. government instituted gain-of-function pause, including but not limited to communications regarding stopping or pausing any of EcoHealth's grants.
8. All documents and communications regarding the letter in *The Lancet* entitled "Statement in support of the scientists, public health professionals, and medical professionals of China combatting COVID-19."

In addition to the above requests, please also produce any and all documents and information and include the Select Subcommittee on all activities produced in response to or resulting from the Committee on Energy and Commerce's February 2, 2023 request to you.

Further, we also renew our request for testimony. Accordingly, Select Subcommittee staff will contact you to schedule transcribed interviews with the following individuals, reserving the right to conduct follow-up interviews or request testimony from other witnesses pertinent to our investigation.

1. Dr. Peter Daszak, President;
2. Dr. Aleksei Chmura, Chief of Staff;
3. Dr. Kevin Olival, Vice President for Research;
4. Dr. Armine Arustamyan, Chief Financial Officer; and
5. Dr. Hume Field, Science and Policy Advisor.

The Select Subcommittee on the Coronavirus Pandemic is authorized to investigate "the origins of the Coronavirus pandemic, including but not limited to the Federal Government's funding of gain-of function research" and "executive branch policies, deliberations, decisions, activities, and internal and external communications related to the coronavirus pandemic" under H. Res. 5. Further, the Committee on Oversight and Accountability is authorized to investigate "any matter" at "any time" pursuant to House Rule X. 




