



# 7 bills Passed; 1 Signed Into Law

- 1) H. J. Res. 26/ P.L. 118-1 – disapproving the D.C. Council's soft-on-crime bill (Rep. Clyde) (FIRST law passed this Congress)
- 2) H. J. Res 24 – disapproving the D.C. Council's law allowing foreign nationals, including illegal immigrants, to vote in local elections (Chairman Comer)
- 3) H.R. 347 – REIN IN Act (Rep. Stefanik)
- 4) H.R. 300 – Settlement Agreement Information Database Act (Rep. Palmer)
- 5) H.R. 159 – Chance to Compete Act (Rep. Foxx)
- 6) H.R. 140 – Protecting Speech from Government Interference Act (Chairman Comer)
- 7) H.R. 139 – SHOW UP Act (Chairman Comer)



## Other Key Wins:

Obtained records for Biden family associates revealing members of the Biden family received over \$1 million in incremental payments from a Chinese company through a third party.



Two transcribed interviews with officials about President Biden's mishandling of classified documents.

Gained access to the Biden family and their associates' suspicious activity reports.
