Dear Ms. Hirsh Naftali,

The Committee on Oversight and Accountability writes to inquire about your purchase of artwork by Hunter Biden, the son of President Joe Biden. Reports have identified you as the purchaser of at least one of these pieces, which have been priced as high as \$500,000.<sup>1</sup> Additionally, you have been appointed by President Joe Biden to the Commission for the Preservation of America's Heritage Abroad (Commission), a position in the Administration that Hunter Biden had previously arranged to be filled by Eric Schwerin, his longtime business partner. These facts raise the Committee's concerns, and the Committee seeks documents and information regarding your purchase of Hunter Biden art.

The White House has stated that "Hunter Biden would be walled off from knowing the identities of his buyers in an attempt to separate his business dealings from his father's administration."<sup>2</sup> Abbe Lowell, Hunter Biden's lawyer, told reporters that the gallery "does not disclose the names of any purchasers to Mr. Biden."<sup>3</sup> This system, however, seems to have failed, because your identity as a purchaser of this art has become public. Your position on the Commission is particularly suspicious because of Hunter Biden's previous actions to elevate his business partner—Eric Schwerin—to the same post while his father was Vice President.<sup>4</sup> White House visitor logs revealed that you visited the White House at least 13 times since December 2021.<sup>5</sup>

The Committee is engaged in the legislative process, as it is analyzing potential legislation it has deemed necessary to provide transparency to the American people. The

Committee seeks to craft legislative solutions aimed at deficiencies it has identified in the current legal framework regarding ethics laws and disclosure of financial interests related to the immediate family members of Vice Presidents and Presidents—deficiencies that may place American national security and interests at risk. The Committee has released two memoranda that show through subpoenaed bank records how Biden family members and their associates have brought in millions of dollars—including while Joe Biden served as Vice President—from foreign sources by using third parties to conceal the source and nature of the funds. The Committee is concerned Hunter Biden has used his new career as an artist to peddle influence in and access to the White House.


The Committee seeks information related to your purchase of Hunter Biden’s artwork. Please produce the following information and documents to the Committee as soon as possible, but no later than August 11, 2023:

1. All documents and communications between or among you, Georges Bergés, the Georges Bergés Gallery, or any employee or agent thereof;
2. All documents and communications between you and any federal employee regarding the purchase of Hunter Biden’s art;
3. All documents and communications between you and any federal employee regarding your appointment to the Commission; and
4. All documents and communications regarding your visits to the White House since December 2021.

The Committee on Oversight and Accountability is the principal oversight committee of the U.S. House of Representatives and has broad authority to investigate “any matter” at “any time” under House Rule X. Thank you for your prompt attention to this important investigation.
