## AMENDMENT IN THE NATURE OF A SUBSTITUTE TO H.R. 6972

## OFFERED BY MR. COMER OF KENTUCKY

Strike all after the enacting clause and insert the following:

## 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Securing Chain of
- 3 Command Continuity Act".
- 4 SEC. 2. NATIONAL SECURITY COUNCIL MEDICAL INCA-
- 5 PACITY NOTIFICATION ENHANCEMENT.
- 6 Section 3349 of title 5, United States Code, is
- 7 amended by adding at the end the following new sub-
- 8 section:
- 9 "(c)(1) Not later than 24 hours after the head of an
- 10 Executive agency who is a member of the National Secu-
- 11 rity Council becomes medically incapacitated or 24 hours
- 12 in advance of a planned medical procedure where incapaci-
- 13 tation is known or may be reasonably assumed, the person
- 14 serving or who will be serving in an acting capacity as
- 15 such head or, if no person is or will be so acting, the first
- 16 assistant to the office of such head, shall submit to the
- 17 appropriate Federal officials a notification that such head
- 18 is or will be medically incapacitated.

1	"(2) If the notification required by paragraph (1)
2	with respect to a head of an Executive agency becoming
3	medically incapacitated is not submitted in accordance
4	with the requirements of such paragraph, not later than
5	72 hours after such head became subject to such medical
6	incapacity the person serving in an acting capacity as such
7	head or, if no person is so acting, the first assistant to
8	the office of such head, shall submit to the appropriate
9	Federal officials a report including—
10	"(A) the name of each individual who served in
11	an acting capacity as such head pursuant to such
12	medical incapacity and, for each such individual—
13	"(i) the dates of such service;
14	"(ii) whether such individual was author-
15	ized to serve in such acting capacity; and
16	"(iii) a comprehensive list of resources and
17	authorities allocated to such individual while
18	serving in such acting capacity to ensure that
19	such individual could perform the functions and
20	duties of the office of such head;
21	"(B) an explanation why the notification re-
22	quired by paragraph (1) was not submitted in ac-
23	cordance with the requirements of such paragraph;
24	"(C) the dates of such head's medical incapaci-
25	tation, and if such head has resumed performing the

1	functions and duties of the office, the date such
2	head so resumed performing such functions and du-
3	ties; and
4	"(D) an explanation why such head was medi-
5	cally incapacitated.
6	"(3) In the event the head of an Executive agency
7	remains medically incapacitated on the date the report is
8	submitted under paragraph (2), the person serving in an
9	acting capacity as such head or, if no person is so acting,
10	the first assistant to the office of such head, shall submit
11	periodic updates, as such person or first assistant con-
12	siders appropriate, to such report to the appropriate Fed-
13	eral officials.
14	"(4) In this subsection—
15	"(A) the term 'appropriate Federal officials'
16	means the Executive Office of the President, the
17	Comptroller General of the United States, the Ma-
18	jority Leader of the Senate, the Minority Leader of
19	the Senate, the Speaker of the House of Representa-
20	tives, and the Minority Leader of the House of Rep-
21	resentatives;
22	"(B) the terms 'medical incapacity' and 'medi-
23	cally incapacitated' mean, with respect to the head
24	of an Executive agency, that such head is unable to
25	perform the functions and duties of the office of

1	such head due to sickness, injury, or other medical
2	condition and such inability to perform the functions
3	and duties of the office of such head constitutes a
4	vacancy of the office of such head to which this sec-
5	tion and sections 3345, 3346, 3347, 3348, 3349a,
6	3349b, 3349c, and 3349d apply; and
7	"(C) the term 'National Security Council'
8	means the council established under section 101 of
9	the National Security Act of 1947 (50 U.S.C.
10	3021).".
