Dear Mr. Singham:

The Committee on Oversight and Government Reform is investigating your reported funding of various extremist entities in the United States. Reportedly, you have supported these groups with the aim of causing destruction and division in our country¹—including most recently through ongoing riots and violence in Los Angeles, California. Moreover, the Committee is concerned that you may be engaging in such activities on behalf of the Chinese Communist Party (CCP)—and that your activity may violate the Foreign Agents Registration Act (FARA), 22 U.S.C. § 611 *et seq* and other federal laws. To this end, we request that you provide documents and information demonstrating your funding and control over certain far-left entities, including the Party for Socialism and Liberation (PSL), “a Communist political organization that has fielded presidential candidates since 2008.”²

On July 10, 2024, Marco Rubio, then-Vice Chairman of the U.S. Senate Select Committee on Intelligence and Lindsey Graham, then-Ranking Member of the U.S. Senate Committee on the Judiciary, wrote to Attorney General Merrick Garland raising concerns about your activities on behalf of the CCP.³ The Biden Department of Justice failed to curb your support of civil unrest, and your activities have recently expanded to include the foment of unrest and civil disobedience in Los Angeles—prompting President Trump to call in the National Guard to counter attacks on federal law enforcement officials.⁴ According to data scientist Jennica Pounds, you are “the main backer behind” the PSL, which has organized nationwide protests, including the Los Angeles riots.⁵

Your connection to the PSL is concerning not only because of its role in the ongoing riots, but also because of the PSL’s China ties and other recent activities. According to the *New*

York Post, the PSL is connected to People’s Forum, a “Manhattan-based non-profit which has ties to the Chinese Communist Party – through funding from [you.]”⁶ In addition, Elias Rodriguez, who reportedly confessed to killing the couple outside the Capital Jewish Museum and chanted “free, free Palestine!” was associated with the PSL.⁷ According to the PSL, Rodriguez “had a brief association with one branch of the PSL that ended in 2017.”⁸ Your “association with far-left circles in the U.S. dates back to at least the 1970s.”⁹

According to the *New York Times*, you reside in the People’s Republic of China and have a long track-record of assisting far-left groups, such as Code Pink, that oppose U.S. interests and support U.S. adversaries.¹⁰ You have created an elaborate dark money network which allows you to send funds to a series of non-profits, such as the “United Community Fund” and “Justice Education Fund,” that have almost no real footprints.¹¹ Non-profit filings show that nearly \$1.8 million flowed from these non-profits to Chinese media company Maku Group.¹² Maku’s website shows young people gathering in your office, facing a banner that reads, “Always Follow the Party,” with an image of General Secretary Xi Jinping in the background.¹³ In 2019, you started a consulting business with Chinese partners “active in the propaganda apparatus” of the CCP.¹⁴ Moreover, it appears that you support BreakThrough Media, a platform known for promoting pro-CCP talking points and geopolitical interests.¹⁵ According to the *New York Times*, reporters “tracked hundreds of millions of dollars to groups linked to you that mix progressive advocacy with Chinese government talking points.”¹⁶

These reports suggest that you may have acted as an agent for the CCP. Under General Secretary Xi, the CCP is known for its “Strategy of Sowing Discord,” which “refers to efforts to make internal disputes amongst the enemy so deep that they become distracted from conflict.”¹⁷ If you are, in fact, carrying out this strategy on behalf of the CCP, you may have a FARA registration obligation. In addition, your funding and relationship with the PSL, which has been implicated in the violence and riots in Los Angeles, may violate other federal laws.

To assist the Committee’s oversight of this matter, we request the following documents and information, covering the time period January 1, 2015, to the present, as soon as possible but




1. All documents and communications related to funding from you or at your direction to the Party for Socialism and Liberation (PSL);

3. All documents and communications related to funding from you or at your direction to the ANSWER Coalition;
4. All documents and communications referencing any form of agreement between you among or between the PSL, the People's Forum, the ANSWER Coalition, and any group with ties to the CCP.
