Dear Attorney General Gonzales:

On July 23, 2025, the Subcommittee on Federal Law Enforcement of the Committee on Oversight and Government Reform ("Committee") unanimously voted to approve a motion directing the Committee to authorize and issue a subpoena to you for a deposition. Your tenure as U.S. Attorney General, from 2005 to late 2007, coincided with a time period when the FBI investigated Jeffrey Epstein for sex crimes, an Assistant U.S. Attorney in the Southern District of Florida prepared a draft 60-count indictment of Mr. Epstein, and the U.S. Attorney's Office for the Southern District of Florida offered a plea bargain to Mr. Epstein, leading to the signing of Mr. Epstein's non-prosecution agreement only one week after you left office. Pursuant to this direction, please see the attached subpoena for you to appear at a deposition on August 26, 2025.

On July 6, 2019, federal authorities arrested Mr. Jeffrey Epstein and two days later an indictment was unsealed in the U.S. District Court for the Southern District for New York charging him with sex trafficking of minors and conspiracy to engage in sex trafficking of minors.³ According to the indictment, Mr. Epstein sexually exploited and abused dozens of minor girls at his homes in Manhattan, Palm Beach, and other locations.⁴ Among other things, the indictment alleged that Mr. Epstein enticed girls as young as 14 years old to engage in sex acts with him in exchange for money.⁵ This was not the first time that Mr. Epstein had been investigated for committing sex crimes. In 2008, he pled guilty in Florida state court to two prostitution offenses, and, in exchange, he and his co-conspirators received immunity from

federal prosecution through a non-prosecution agreement that was negotiated during your time as Attorney General.⁶

On August 10, 2019, while in federal custody at the Metropolitan Correctional Center in New York, New York, Mr. Epstein died.⁷ The Chief Medical Examiner of New York City ruled his death a suicide.⁸ Subsequently, on June 28, 2022, Ms. Ghislaine Maxwell was sentenced to 20 years in prison for conspiring with Mr. Epstein to sexually abuse minors.⁹

The facts and circumstances surrounding both Mr. Epstein and Ms. Maxwell's cases have received immense public interest and scrutiny. At the outset of the 119th Congress, on February 11, 2025, the Committee and the Task Force on the Declassification of Federal Secrets sent a letter to the Department of Justice ("Department") requesting a briefing regarding documents in the Department's possession regarding "the investigation into and prosecution of Jeffrey Epstein." On May 8, the Task Force sent another letter to the Department requesting the public release of "the entirety of the Epstein files" and a briefing regarding the release of these files. 11

On July 17, President Donald Trump posted on Truth Social, "I have asked Attorney General Pam Bondi to produce any and all pertinent Grand Jury testimony, subject to court approval..." On July 18, in response to the President's direction, Attorney General Bondi posted on X, "[o]ur motion has been filed." ¹³

On July 22, Attorney General Bondi posted a statement from Deputy Attorney General Todd Blanche on X stating, "If Ghislaine Maxwell has information about anyone who has committed crimes against victims, the FBI and DOJ will hear what she has to say." ¹⁴ Further, Deputy Attorney General Blanche stated, "This Department of Justice does not shy away from uncomfortable truths, nor from the responsibility to pursue justice wherever the facts may lead." ¹⁵

While the Department undertakes efforts to uncover and publicly disclose additional information related to Mr. Epstein and Ms. Maxwell's cases, it is imperative that Congress conduct oversight of the federal government's enforcement of sex trafficking laws generally and specifically its handling of the investigation and prosecution of Mr. Epstein and Ms. Maxwell. The Committee may use the results of this investigation to inform legislative solutions to improve federal efforts to combat sex trafficking and reform the use of non-prosecution agreements and/or plea agreements in sex-crime investigations. Because you were Attorney General during the time when Mr. Epstein was under investigation by federal authorities and a non-prosecution agreement with Mr. Epstein was negotiated by the Department of Justice, the Committee believes that you possess knowledge and information relevant to its investigation.

The Committee on Oversight and Government Reform is the principal oversight committee of the U.S. House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X. ¹⁶ Further, pursuant to House Rule XI clause 2(k)(6) "...the chair shall receive and the committee shall dispose of requests to subpoena additional witnesses." On July 23, 2025, the Subcommittee on Federal Law Enforcement of the Committee on Oversight and Government Reform ("Committee") unanimously voted to approve a motion directing the Committee to authorize and issue a subpoena to you for a deposition. During your tenure as U.S. Attorney General from 2015 to 2017, the U.S. Department of Justice was litigating against victims of Mr. Jeffrey Epstein who alleged that the Department had violated their rights under the Crime Victims Rights Act, 18 U.S.C. § 3771, in negotiating a non-prosecution agreement with Mr. Epstein. Pursuant to this direction, please see the attached subpoena for you to appear at a deposition on September 9, 2025.

Your second tenure as U.S. Attorney General, beginning in early 2019, coincided with the federal sex trafficking investigation of Jeffrey Epstein, as well as his eventual death while in federal detention. It also coincided with the federal indictment of Ms. Ghislaine Maxwell, which stemmed from the Epstein investigation. Pursuant to this direction, please see the attached subpoena for you to appear at a deposition on August 18, 2025.

On July 6, 2019, while you were Attorney General, federal authorities arrested Mr. Jeffrey Epstein and two days later an indictment was unsealed in the U.S. District Court for the Southern District for New York charging him with sex trafficking of minors and conspiracy to engage in sex trafficking of minors.⁴ According to the indictment, Mr. Epstein sexually exploited and abused dozens of minor girls at his homes in Manhattan, Palm Beach, and other locations.⁵ Among other things, the indictment alleged that Mr. Epstein enticed girls as young as 14 years old to engage in sex acts with him in exchange for money.⁶ This was not the first time that Mr. Epstein had been investigated for committing sex crimes. In addition, while you were Attorney General, the Department may have been engaging in an investigation of Mr. Epstein that led to his final arrest in 2019. Pursuant to this direction, please see the attached subpoena for you to appear at a deposition on August 28, 2025.

On July 6, 2019, federal authorities arrested Mr. Jeffrey Epstein and two days later an indictment was unsealed in the U.S. District Court for the Southern District for New York charging him with sex trafficking of minors and conspiracy to engage in sex trafficking of minors.³ According to the indictment, Mr. Epstein sexually exploited and abused dozens of minor girls at his homes in Manhattan, Palm Beach, and other locations.⁴ Among other things, the indictment alleged that Mr. Epstein enticed girls as young as 14 years old to engage in sex acts with him in exchange for money.⁵ This was not the first time that Mr. Epstein had been investigated for committing sex crimes. In 2008, he pled guilty in Florida state court to two prostitution offenses, and, in exchange, he and his co-conspirators received immunity from federal prosecution through a non-prosecution agreement.⁶

Dear Attorney General Holder:

On July 23, 2025, the Subcommittee on Federal Law Enforcement of the Committee on Oversight and Government Reform ("Committee") unanimously voted to approve a motion directing the Committee to authorize and issue a subpoena to you for a deposition. During your tenure as U.S. Attorney General from 2009 to 2015, victims of Mr. Jeffrey Epstein filed a lawsuit alleging that the U.S. Department of Justice had violated their rights under the Crime Victims Rights Act, 18 U.S.C. § 3771, in negotiating a non-prosecution agreement with Mr. Epstein, and the Department proceeded to litigate against those victims. Pursuant to this direction, please see the attached subpoena for you to appear at a deposition on September 30, 2025.

On July 6, 2019, federal authorities arrested Mr. Jeffrey Epstein and two days later an indictment was unsealed in the U.S. District Court for the Southern District for New York charging him with sex trafficking of minors and conspiracy to engage in sex trafficking of minors.³ According to the indictment, Mr. Epstein sexually exploited and abused dozens of minor girls at his homes in Manhattan, Palm Beach, and other locations.⁴ Among other things, the indictment alleged that Mr. Epstein enticed girls as young as 14 years old to engage in sex acts with him in exchange for money.⁵ This was not the first time that Mr. Epstein had been investigated for committing sex crimes. In 2008, he pled guilty in Florida state court to two prostitution offenses, and, in exchange, he and his co-conspirators received immunity from federal prosecution through a non-prosecution agreement.⁶

On August 10, 2019, while in federal custody at the Metropolitan Correctional Center in New York, New York, Mr. Epstein died.⁷ The Chief Medical Examiner of New York City ruled his death a suicide.⁸ Subsequently, on June 28, 2022, Ms. Ghislaine Maxwell was sentenced to 20 years in prison for conspiring with Mr. Epstein to sexually abuse minors.⁹

The facts and circumstances surrounding both Mr. Epstein and Ms. Maxwell's cases have received immense public interest and scrutiny. At the outset of the 119th Congress, on February 11, 2025, the Committee and the Task Force on the Declassification of Federal Secrets sent a letter to the Department of Justice ("Department") requesting a briefing regarding documents in the Department's possession regarding "the investigation into and prosecution of Jeffrey Epstein." On May 8, the Task Force sent another letter to the Department requesting the public release of "the entirety of the Epstein files" and a briefing regarding the release of these files. 11

On July 17, President Donald Trump posted on Truth Social, "I have asked Attorney General Pam Bondi to produce any and all pertinent Grand Jury testimony, subject to court approval..." On July 18, in response to the President's direction, Attorney General Bondi posted on X, "[o]ur motion has been filed." ¹³

On July 22, Attorney General Bondi posted a statement from Deputy Attorney General Todd Blanche on X stating, "If Ghislaine Maxwell has information about anyone who has committed crimes against victims, the FBI and DOJ will hear what she has to say." ¹⁴ Further, Deputy Attorney General Blanche stated, "This Department of Justice does not shy away from uncomfortable truths, nor from the responsibility to pursue justice wherever the facts may lead." ¹⁵
