Dear Mr. Neering:

The Subcommittee on Delivering on Government Efficiency is investigating Planned Parenthood Federation of America, Inc. (Planned Parenthood) and its affiliates' provision of abortion services and "gender affirming care" for minors. On June 13, 2025, the Subcommittee sent a letter to Planned Parenthood requesting documents and communications related to the increased provision of abortion services and the provision of gender affirming care services to minors without parental consent.¹ As of now—nearly one year later—Planned Parenthood has yet to fully comply with the Subcommittee's letter and provide the requested documents and communications.

Planned Parenthood received nearly \$800 million in federal funds in fiscal year (FY) 2023² and is the second largest provider of gender hormone therapies in the United States.³ The Subcommittee is concerned that Planned Parenthood and its affiliates, including Planned Parenthood of Northern, Central, and Southern New Jersey, Inc. (PPNCSNJ), may be commingling federal funds and using them for unpermitted purposes. It is imperative that federal funds provided to Planned Parenthood via Title X of the Public Health Service Act (Title X), Medicaid, and the Children's Health Insurance Program (CHIP) are administered in compliance with applicable laws and regulations.⁴

Therefore, the Subcommittee seeks documents and information from PPNCSNJ about its delivery of these services and stewardship of taxpayer funds. To assist the Subcommittee's oversight of this matter, we request the following information, covering the period January 1, 2020, to present, as soon as possible but no later than June 1, 2026:

1. All PPNCASNJ's non-public financial statements and annual reports, including but not limited to Internal Revenue Service Form 990, Return of Organization Exempt from Income Tax;
2. All documents and communications related to the formation and structure of PPNCASNJ, including but not limited to articles of incorporation, bylaws, and codes of conduct;
3. A list of all independent ancillary or other related organizations supported by or under the control of PPNCASNJ, including but not limited to any Virtual Health Centers providing telehealth services;
4. All PPNCASNJ policies and procedures for complying with state and federal laws and regulations regarding gender affirming care and parental consent;
5. All informed consent documentation provided to patients, parents, or guardians related to abortion or gender affirming care services at PPNCASNJ and/or its ancillary or other related organizations;
6. All PPNCASNJ policies, procedures, or guidelines for compliance with the federal Partial-Birth Abortion Ban Act⁵ and compliance with the federal Born-Alive Infants Protection Act;⁶
7. All PPNCASNJ policies, procedures, or guidelines for abortions performed on viable or perivable fetuses;
8. All documents and communications related to the initial and continuing accreditation status of PPNCASNJ as an affiliate of Planned Parenthood;
9. An itemized list of sums PPNCASNJ received in each of the past five years from federal government programs, grants, or other sources of federal funds, including but not limited to Title X healthcare services; and
10. A list of every healthcare service provided to patients by PPNCASNJ and the frequency with which those services are provided.

The Committee on Oversight and Government Reform is the principal oversight committee of the U.S. House of Representatives and has broad authority to investigate “any matter” at “any time” under House Rule X.
