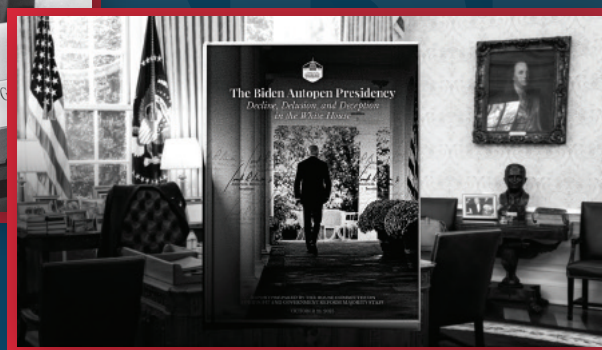

EXPOSING WASTE, FRAUD, & ABUSE IN STATE-ADMINISTERED FEDERAL PROGRAMS

The Oversight Committee uncovered billions of taxpayer dollars lost to fraud, waste, and abuse in federally funded programs administered by the states.

Our investigations into Minnesota, California, and Ohio exposed how weak oversight, poor accountability, and broken payment systems **allowed taxpayer dollars to be stolen while vulnerable Americans were left behind**. Through hearings, letters, reports, and oversight, we demanded answers from state officials and federal agencies responsible for safeguarding these programs.

After exposing these failures, **the House passed eleven Oversight Committee bills with bipartisan votes** to strengthen fraud prevention, improve payment verification, expand fraud detection tools, and stop improper payments before taxpayer dollars are lost. These reforms shift the federal government away from its costly “pay-and-chase” model toward **preventing fraud before it occurs**.

A Government Accountability Office (GAO) report requested by Chairman James Comer confirmed that **between \$233 billion and \$521 billion is lost to fraud every year across federal programs** and operations and found that many of the Committee’s bipartisan reforms directly address GAO’s recommendations.

We will continue exposing fraud, protecting taxpayer dollars, and ensuring federal benefits reach those who truly qualify.

EXPOSING THE BIDEN AUTOPEN PRESIDENCY



Chairman James Comer and Oversight Republicans released a **bombshell report** exposing the truth behind **Joe Biden's cognitive decline** and who was really running the show.

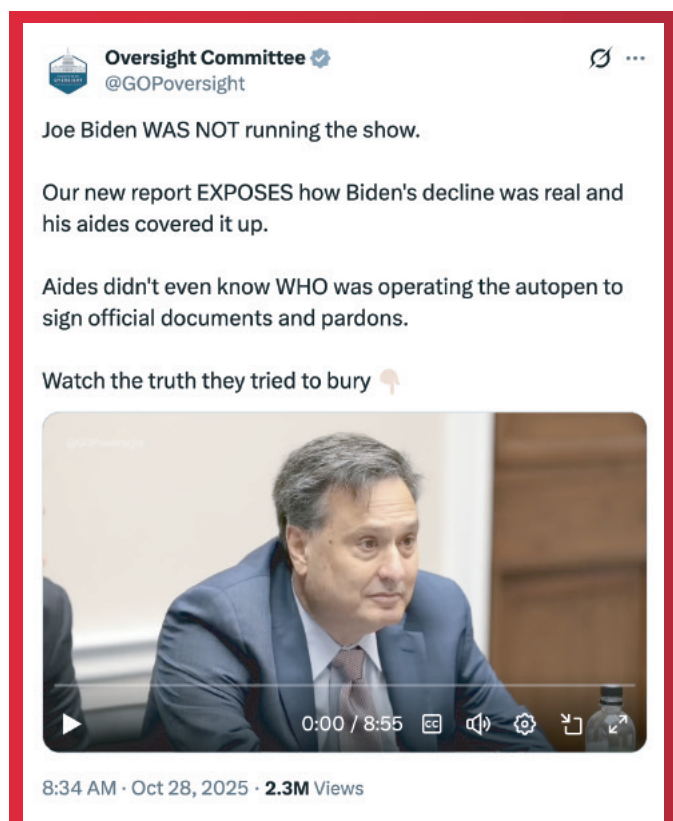
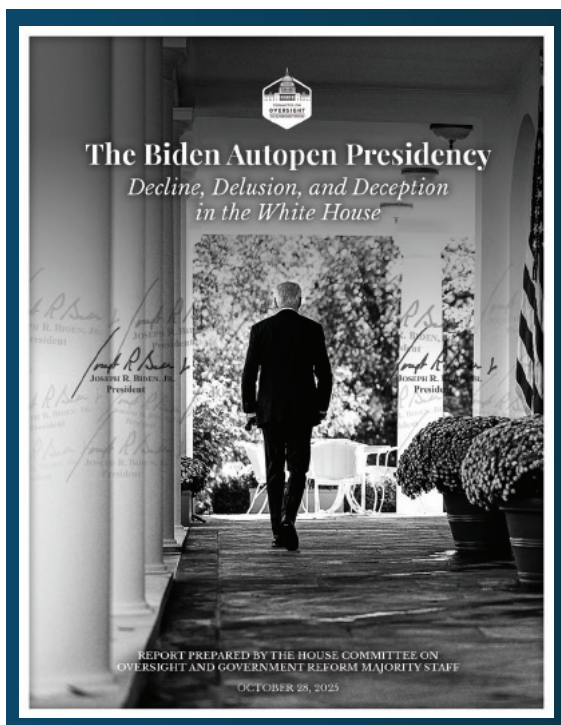
Through transcribed interviews and depositions with Biden's own former senior staff, we uncovered that while Biden struggled to perform his duties, **critical decisions were made behind closed doors without a clear chain of command.**

That included using an autopen to sign executive actions, pardons, and major policy directives without clear approval from Joe Biden.

Staffers close to Biden admitted **his decline was real**. Shockingly, some did not even know who was authorizing signatures in his name or using the autopen. Others invoked the Fifth, refused to testify, and stonewalled the Committee at every turn.

This isn't just a cover-up—it's the biggest political scandal in American presidential history.

MAKING LIFE MORE AFFORDABLE FOR AMERICANS



Oversight advanced policies to **lower costs for American families, increase competition**, and **reduce unnecessary government barriers** that make everyday life more expensive.

We launched investigations into **surveillance pricing**, demanding answers from major companies about **whether Americans' personal data is being used to charge different consumers different prices for the same products**.

The Committee also advanced the bipartisan **Pharmacists Fight Back Act** to rein in pharmacy benefit managers (PBMs), **lower prescription drug costs**, protect independent pharmacies, and increase transparency in the prescription drug marketplace.

We also **examined the federal policies** fueling America's housing affordability **crisis**, including excessive regulation that drives up construction costs and limits the supply of affordable housing.

We also **hosted a forum** on the **growing use of lawfare against American agriculture**, examining how burdensome regulations and politically motivated lawsuits threaten family farms and food producers.

Beyond oversight, **the Committee advanced legislation to reduce regulatory burdens and improve transparency across the federal government**.

Chairman Comer's bipartisan **GOOD Act** increases transparency by requiring agencies to publicly disclose guidance documents.

Representative Lisa McClain's **Information Quality Assurance Act** strengthens the scientific integrity of federal rulemaking by requiring agencies to rely on the best available evidence.

Representative Eric Burlison's **Guidance Clarity Act** makes clear that agency guidance documents do not carry the force of law.

We will continue fighting to lower costs, eliminate unnecessary red tape, and ensure the federal government works for American families.

INVESTIGATION OF POLITICALLY MOTIVATED DISCRIMINATION IN THE U.S. FINANCIAL SYSTEM

We launched an investigation into **how the Biden Administration continued the left's ongoing efforts to deprive industries they don't like from access to capital.**

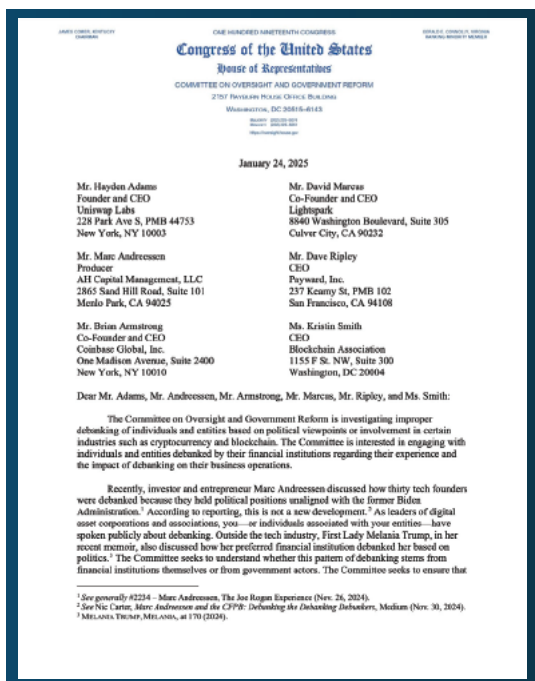
The Committee sought evidence showing banks, regulators, and insurers **targeted lawful Americans and businesses for their political views or participation in disfavored industries**, especially cryptocurrency and blockchain innovation.

Through letters, whistleblower testimony, and unredacted documents, we exposed how **federal regulators pressured financial institutions to debank tech founders, crypto companies, and even members of the Trump family**, cutting them off from basic financial services without due process.

Regulators issued secret pause letters and used their regulatory power to suppress entire industries they opposed, driving innovation overseas and threatening payrolls and operations here at home.

We continue to confront the left's effort to reshape our economy and society by using capital and capital markets to fulfill the wishes they can't win at the ballot box.

MAKING D.C. **SAFE & BEAUTIFUL**



This Congress, we took decisive action to **restore safety, accountability, and order in our nation's capital** after years of soft-on-crime failure by D.C. leadership.

Through hearings, legislation, and oversight, the Committee **exposed how radical D.C. policies fueled a juvenile crime crisis, rigged crime statistics, and left residents and visitors at risk.** We highlighted the clear **success of President Trump's federal intervention**, which delivered historic reductions in violent crime, robberies, and carjackings.

The House passed several of our bills to **codify President Trump's agenda, strengthen law enforcement, end sanctuary policies, protect due process for police officers, restore the integrity of elections, and hold violent offenders accountable.**

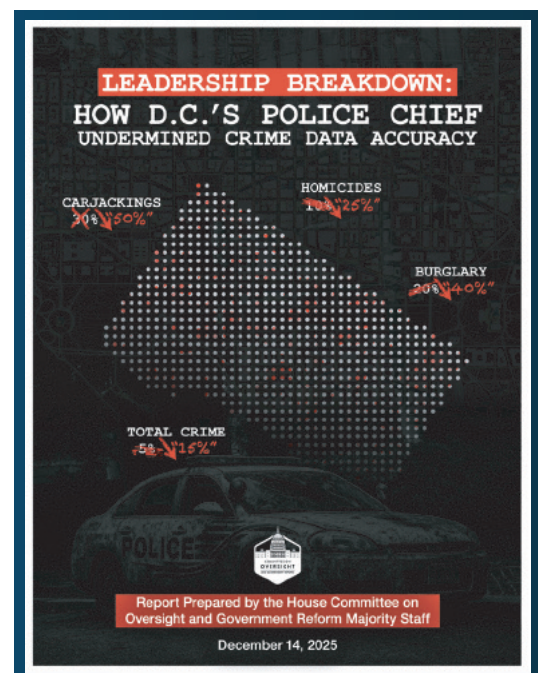
We also launched a bombshell investigation into **manipulated crime data inside the Metropolitan Police Department.** House Democrats [mocked our investigation](#) as a “political stunt,” but the MPD’s own investigation **confirmed that senior officials manipulated crime statistics to hide the true scope of violence.** Multiple high-ranking officials were terminated, proving our investigation was right all along.

We also delivered results to make D.C. beautiful again by leading the bipartisan effort to **unlock the long-abandoned RFK Stadium site for redevelopment, economic growth, and revitalization.**

Our work sent a clear message:
Congress will not tolerate lawlessness, data manipulation, or political negligence in the nation's capital.

EXPOSING BIDEN'S **GREEN NEW DEAL SCAM** & WEAPONIZED ENVIRONMENTAL ENFORCEMENT

In 2023, **Biden's EPA handed out \$20B** from the Greenhouse Gas Reduction Fund (GGRF) **to just eight nonprofits—all with DEEP TIES to Democrat power players.**

We released a major report revealing the Biden EPA's "Green New Deal" scheme used the GGRF to funnel tens of billions to left-leaning nonprofits, **prioritizing politics over merit and leaving taxpayer dollars vulnerable to waste, fraud, and abuse.**

A lot of this money went to ridiculous things like **\$435K salaries with lavish travel budgets, "zero-emission" brewery equipment, housing for artists, and a bar with a communal kitchen.**

It was never about the climate. It was about funneling taxpayer cash to Democrat-aligned nonprofits.

We also held a hearing exposing how Biden-era DOJ and EPA enforcement went rogue, using **aggressive raids and consent decrees to intimidate citizens and crush small businesses.**

THE BIDEN BORDER CRISIS: HOLDING SANCTUARY MAYORS & GOVERNORS ACCOUNTABLE

President Trump secured the border on day one, but it is our job to expose the truth and bring accountability to what happened during the Biden Border Crisis. **We brought sanctuary city mayors and state governors before Congress and demanded answers under oath.**

In public hearings, we uncovered how Democrat leaders in Chicago, Denver, New York City, and Boston **obstructed federal immigration enforcement, refused to cooperate with ICE detainers, and put officers and the public at risk** by forcing arrests to happen on the streets instead of in secure jails.

We held Illinois **Governor JB Pritzker, Minnesota Governor Tim Walz, and New York Governor Kathy Hochul** accountable for policies that **shield criminal illegal aliens, drain taxpayer resources, and endanger Americans.**

We also launched investigations into the fiscal and public safety consequences of sanctuary policies, culminating in an interim Committee report **exposing how sanctuary jurisdictions protect criminal illegal aliens, obstruct federal immigration enforcement, burden taxpayers, and put Americans at risk.**

The report detailed how **more than 662,000 criminal illegal aliens were roaming free in the United States**, sanctuary policies increase costs for working families, and local officials force ICE officers to arrest dangerous criminals on neighborhood streets instead of in secure custodial settings.

MAKING THE GOVERNMENT MORE EFFICIENT & EFFECTIVE



We exposed how the **Biden Administration and Democrats in Congress turned taxpayer dollars into a slush fund** for radical NGOs, biased media outlets, and wasteful federal programs.

Through hearings and investigations, **we uncovered how billions of taxpayer dollars flowed to politically connected nonprofits** that promoted open borders, the Green New Deal scam, and other left-wing causes with little oversight or accountability.

We also held NPR and PBS executives accountable for using public funds to push partisan propaganda, confirming these outlets no longer serve the public's interest and should not be subsidized by hardworking Americans.

Our oversight delivered real results. The House enacted President Trump's rescissions package, **locking in \$9.4 billion in DOGE cuts and eliminating taxpayer funding for woke foreign aid projects** and the public broadcasting bureaucracy.

The House also passed bipartisan Committee reforms **to save up to \$500 million** by modernizing the federal employee relocation process, exposing billion-dollar federal boondoggles, improving spending transparency, and expanding protections for whistleblowers who expose wrongdoing.

The Oversight Committee has **exposed hundreds of billions lost to fraud and improper payments.**

Witnesses at our hearings made clear that **the Biden Administration expanded broken programs** while ignoring basic safeguards, fueling waste and skyrocketing the national debt.

Beyond spending abuse, we advanced legislation to **improve transparency, modernize federal IT systems, strengthen cybersecurity, and force long-overdue accountability at the Department of Defense.**

We are restoring fiscal discipline, modernizing government operations, and ensuring taxpayer dollars actually serve the American people instead of the Washington swamp.

PROTECTING AMERICANS & OUR NATIONAL SECURITY



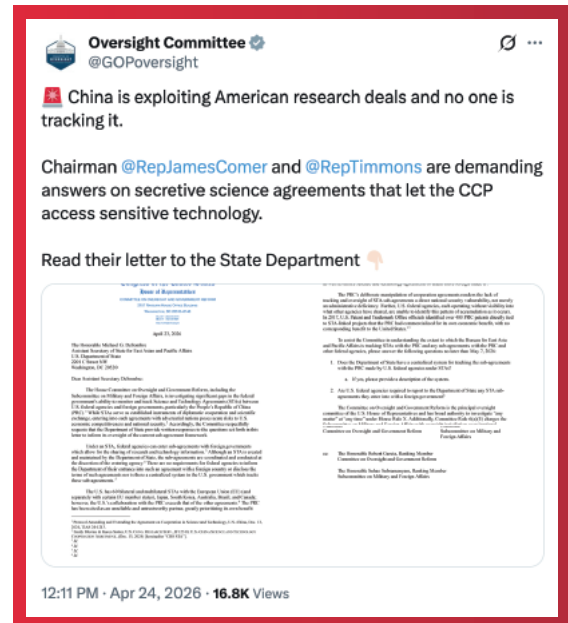
We uncovered the escalating national security threats posed by the **Chinese Communist Party**, foreign **exploitation of U.S. laws**, and **critical failures within the federal government's security infrastructure**.

Chairman Comer launched investigations **into the CCP's growing influence over the Western Hemisphere**, including its role in Panama Canal operations, CCP-linked entities acquiring land near U.S. military installations, and the **national security risks posed by science and technology agreements that allow China to exploit American research** and innovation.

We also investigated **businesses profiting from birth tourism**, exposing how foreign nationals, particularly from China and Russia, exploit U.S. immigration law to obtain birthright citizenship for their children, creating serious national security concerns.

The Committee also examined the Department of Defense's **long-delayed National Background Investigation Services (NBIS) program**, demanding accountability for years of delays, ballooning costs, and outdated technology that threaten the federal government's security clearance process and the protection of sensitive national security information.

Our oversight is strengthening America's defenses by **exposing foreign threats**, **closing security vulnerabilities**, and **holding federal agencies accountable** for protecting our nation's security.



This work makes clear that national security starts with vigilance and accountability.

UNCOVERING THE EPSTEIN DOCUMENTS & DEFEATING THE DEMOCRATS' HOAX

Chairman Comer launched an investigation into **the government's handling of the Jeffrey Epstein and Ghislaine Maxwell cases.**

To date, we have held nineteen interviews, obtained bank records, and subpoenaed records from the Department of Justice and the Epstein Estate to give Americans transparency on the most controversial case in recent times.

Our investigation also **uncovered new allegations of criminal misconduct**, prompting Chairman Comer and Republican lawmakers **to refer two previously undisclosed names to the DOJ** for investigation.

The Committee also **unanimously advanced a resolution to hold Leon Black in contempt of Congress for defying subpoenas**, and the House swiftly approved **the resolution by unanimous consent.**

Chairman Comer also introduced the **Survivor's Voice Protection Act** to ensure survivors can speak freely about sexual abuse despite nondisclosure agreements and strengthen protections against the grooming of minors.

Democrats tried to create a *hoax* against President Trump that has been **repeatedly debunked by documents and facts.** This included censoring photos of President Trump with a group of adult female models to create a narrative against him, and **the Legacy Media ran with it.**

In fact, our investigation revealed how Democrats like **Minority Leader Hakeem Jeffries solicited campaign contributions from Epstein,** and **Virgin Islands Delegate Stacey Plaskett colluded with Epstein during a congressional hearing. They were caught red-handed.**

We will continue to seek justice for survivors and expose the full truth.
